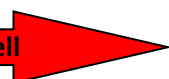

Hillcrest Evangelical Church GLOW GIRLZ Permission & Release Form

Individuals attending **GLOW GIRLZ** at Hillcrest Evangelical Missionary Church Fellowship (“Hillcrest Church”) will be participating in activities onsite. These activities (collectively, the “Hillcrest Church Activities”) may include, but are not limited to, games, gym activities, crafts, offsite outings. In consideration of Hillcrest Church permitting your child to participate in Hillcrest Church Activities, the parent/guardian (in its own capacity and for and on behalf of the child listed below and heirs, estates and legal representatives of the parent/guardian/child) agrees as follows:

General Consent – The parent/guardian hereby gives consent for their child to participate in the Hillcrest Church Activities.

Transportation Consent – The parent/guardian gives consent for the child to be transported by bus, van, or other vehicle, whether personal or otherwise, and whether or not operated by one or more of the Releasees (as defined below).

Medical Consent - In the event that the parent/guardian cannot be reached in an emergency, he/she gives consent to the physician, medical practitioner or dentist selected by the Releasees (as defined below) to hospitalize, secure proper treatment and/or order injection, anesthesia or surgery for his/her child as deemed necessary.

Liability Release and Indemnity - By signing this release, the parent/guardian, in its own capacity and for and on behalf of the child, (and for and on behalf of the heirs, estates and legal representatives of the parent/guardian/child) confirms that the CHILD MAY BE EXPOSED TO THE RISKS OF PERSONAL AND/OR PROPERTY DAMAGE OR LOSS, BODILY INJURY, DISABILITY AND/OR DEATH in connection with Hillcrest Church Activities, AGREES TO ASSUME AND ACCEPT ALL RISKS AND HAZARDS associated with the Hillcrest Church Activities, AGREES TO WAIVE ANY AND ALL CLAIMS AND RIGHTS, INCLUDING LEGAL ACTION, against Hillcrest Church, its directors, officers, trustees, employees, members, volunteers, agents or similar individuals or entities (collectively, the “Releasees”), AS A RESULT OF OR ARISING OUT OF ANY PERSONAL AND/OR PROPERTY DAMAGE OR LOSS, BODILY INJURY, DISABILITY AND/OR DEATH, WHETHER OR NOT CAUSED BY OR CONTRIBUTED TO BY THE NEGLIGENCE OF THE RELEASEES OR THOSE FOR WHOM THE RELEASEES ARE RESPONSIBLE AT LAW. Furthermore, the parent/guardian, in its own capacity and for and on behalf of the child (and for and on behalf of the heirs, estates and legal representatives of the parent/guardian/child), AGREES TO INDEMNIFY AND SAVE HARMLESS THE RELEASEES from and against any and all liability which may result from any such personal and/or property damage or loss, bodily injury, disability and/or death WHETHER OR NOT CAUSED BY OR CONTRIBUTED TO BY THE NEGLIGENCE OF THE RELEASEES OR THOSE FOR WHOM THE RELEASEES ARE RESPONSIBLE AT LAW.

Any provision of this document which is prohibited or unenforceable in any jurisdiction shall, as to such jurisdiction, be ineffective to the extent of such prohibition or unenforceability without invalidating the remaining provisions hereto, and any such prohibition or unenforceability in any jurisdiction shall not invalidate or render unenforceable such provision in any other jurisdiction.
